Explanation of Responses:

- On June 7, 2010, each of The Marc Daniel Miller 2009 GRAT, The Marni Spencer 2009 GRAT and The Abby Miller King 2009 GRAT transferred 22,897 shares of Class B Common Stock to Alan B. Miller. The transfer resulted in a change of beneficial ownership from indirect to direct. Mr Miller's pecuniary interest in these shares is unchanged.
- On June 9, 2010, Mr. Alan B. These shares were previously directly held by Mr. Alan B. Miller and the transfer resulted in a change of beneficial ownership from direct to indirect.
